We have one more survey cycle before we begin bargaining and should have the results in early 2015. Hopefully we will see better results, which would strengthen our position at the bargaining table.

I would be honored to serve again as PECG's Vice President Collective Bargaining. And whatever the outcome of the upcoming corporate elections, as a member of the Bargaining Team, I will continue to work hard to represent PECG's membership.

My name is Alan Escarda and I have had the privilege of serving as your Supervisor Representative on PECG's corporate board for the last two years. If elected, I pledge to continue to work on the two goals that I first set in 2013. First and foremost is to correct the long overdue salary inequity between senior supervisors and senior specialists and secondly to improve the flow of information regarding PECG's efforts to represent our senior and managerial members' interests.

While we did not achieve our main financial goal last year, we laid the groundwork for success this year! As I write this candidate statement the funding to correct the supervisor salary inequity has made it through the May Revise. We will continue to monitor and shepherd the salary inequity funding through the budgetary process until the Governor signs the final budget and CalHR submits a pay letter to the State Controller's Office to increase our salaries. I will not rest until this goal is achieved.

To improve communications with my fellow supervisors, I visited as many sections as possible to gather input and share information. Then, with the help of the Meet and Confer team, I developed a supervisor communication plan that set clear expectations on the roles and responsibilities between PECG staff, Section Supervisor Representatives and me. Finally, I joined the Excluded Employee Council to represent PECG in advising the Administration to provide better pay and working conditions for supervisors and managers.

While our long standing goal of rectifying the salary inequity appears to be imminent- much work remains. If elected- I will add three new goals for next year:

- 1) Address salary compaction for managers. The Meet and Confer team advocates linking senior pay to the annual salary survey. In addition, I propose a minimum10% pay differential between Supervisors and senior supervisors and managers and their direct reports.
- 2) The Administration now proposes to phase in retirement compensation over a longer period than what is required for rank and file. I will seek a return to the single highest year of pay for the basis of retirement compensation.
- 3) Supervisors and managers cannot be left behind again when rank and file receives their 3.3% raise in July 2015. I will press the Administration to avoid creating another salary inequity situation.

With your help, I would be honored to lead this effort again as your Supervisory Vice President.

Welcome High Speed Rail Authority members! It has been an honor serving as VP at Large, representing nearly 5,000 state-employed engineers and related professionals at over 20 Departments. Many non-Caltrans members are responsible for designing and inspecting California's infrastructure. These include our members at the Department of Water Resources who engineered the State Water Project - the nation's largest state - built water and power development and conveyance system.

At Large members are trusted with improving air and water quality, ensuring Californians have safe workplaces, schools and hospitals, and managing state natural resources.

In recent years, PECG has expanded its outreach program with the production of two award winning documentaries on climate change. We have taken our issues to Washington. We have taken a position to support a water bond and have been working judiciously on ensuring that state engineers continue to be in charge of the State Water Project.

We are pursuing the "Environmental Engineer" Title Act, which will provide opportunity for our members to obtain a professional license.

We have been advocating with policy makers for "Right Sizing" Departments that have been challenged with inadequate staffing.

This year, PECG successfully worked with the legislators and the administration to alleviate the major concern of more than 170 affected members at CDPH to continue to service the program that has been with public health for 99 years without transferring employees to other locations, as they are being integrated into SWRCB. This change is a reminder of how vulnerable we are and how important PECG is with our employment conditions.

Protecting our pay and benefits are issues that have always been in the forefront for this organization. My goal is to continue to take an active part to protect our interests on employment and professional issues at the worksite, and in the state Legislature. I will continue to work closely with the Bargaining Team as well as the Meet and Confer Team, fellow Officers, Section leaders, and PECG Staff on our issues. Thank you again for your consideration.
