## PECG Orange County Section Retirees 2020

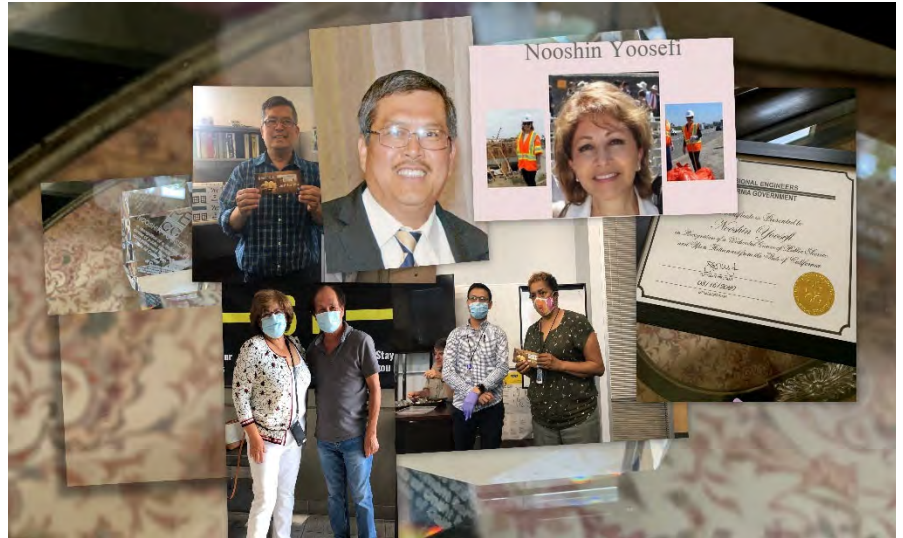
