PECG Updates

Leave Buy-Back Program for 2023

Many Unit 9 agencies and departments have announced that they will have a leave buy-back program this year. PECG's Memorandum of Understanding (MOU) Article 5.19 authorizes Unit 9 employees to cash out up to 80 hours of accumulated Vacation or Annual Leave each year if their department determines it has funds available to make the payments. On or before May 1 each year, under the terms of the MOU, each department is supposed to notify employees if the Vacation/Annual Leave cash out will be available. If so, the departments must also let employees know how many hours they can cash out, not to exceed the 80-hour maximum. The State has released guidance extending the same leave buy-back terms to Unit 9 supervisors and managers.

Just as a reminder, Personal Leave Program (PLP) 2020 hours are not eligible to be cashed out under the leave buy-back program.

Under the leave buy-back program, Unit 9 employees who wish to take advantage of the opportunity must submit a request form during the month of May to cash out a portion of their Vacation or Annual Leave. Payments are to be issued by departments in June. Please keep in mind that the cashed-out leave is taxable.
