PECG Weekly Updates

February 2, 2023

As reported in previous Weekly Updates, the State has issued multiple pay letters to provide the 2.5% General Salary Increase (GSI) to all Unit 9 members – rank and file employees and supervisors and managers – effective July 1, 2022, and to implement the many new and improved pay differentials that are part of PECG's 2022-25 Memorandum of Understanding (MOU).

The vast majority of PECG members report having received the GSI and the related back pay. Unfortunately, we continue to hear from members that have yet to receive the differential increases and the associated back pay.

If you have yet to receive your GSI, a differential increase, or the back pay associated with them – please notify your Personnel Specialist immediately. Please also share your circumstance with PECG by emailing us at pecg@pecg.org. We continue to follow up with departments to urge that they take the necessary steps to ensure that Unit 9 employees receive the pay increases they are due as soon as is possible.

For just \$8 per month, PECG retired members under age 70 are automatically enrolled in a \$1,500 Basic Life Insurance plan and also receive \$1,500 of accidental death and dismemberment (AD&D) coverage. At age 70, your dues will drop to \$4 a month because the basic life and AD&D insurance coverage is no longer provided by PECG's insurer.

But retired members regardless of age continue to receive PECG Weekly Updates and the Informer newsletter to keep you up-to-date on important news, including PECG's work to protect your pension, health care, and other retiree benefits. And, as a retired member, if you have any trouble with your retirement benefits, a PECG staff member is just an email or phone call away.

You will also continue to receive PECG's annual pocket and wall calendars and enjoy PECG's low-cost group auto and homeowner insurance, as well as substantial savings on consumer goods and vacation discounts.

This is a good time for a friendly reminder about the Dependent Re-verification Program (DRV), under which all state

employees and retirees with spouses, domestic partners, children, and other dependents enrolled in a state health care plan must provide documentation that those family members are eligible to continue receiving medical and dental benefits. The DRV process runs on a three-year cycle with set deadlines for state employees and retirees to submit eligibility documentation based on your birth month.

According to the State, failure to complete the DRV process will result in the cancellation of health and dental insurance for unverified dependents.

January 13, 2023

On Tuesday, Governor Newsom kicked off the budget debate at the State Capitol with the release of his proposed 2023-24 State Budget for the fiscal year that starts July 1, 2023.

According to the Administration, after years of surpluses, the budget next year will slip into deficit. Specifically, the proposed budget projects a \$22.5 billion deficit in 2023-24 due to a \$29.5 billion decline in tax revenue projections during the current and next fiscal years. Tax revenues are down due to an economy weakened by inflation, federal interest rate hikes, and stock market declines.

The result is a 2023-24 proposed budget that totals \$297 billion, which represents a 3.5% reduction from the current \$308

billion budget. To close the deficit, the Administration proposes to delay or pull back nearly \$20 billion in spending authorized in the last two state budgets, which were marked by historic surpluses. For now, the Administration is not proposing to use the State's \$36 billion in available reserves, including the \$22 billion in the Rainy Day Fund, as part of their deficit reduction plan.

Importantly, the proposed budget provides funding for the Unit 9 general salary increase, and other pay and benefit improvements, due July 1, 2023 - per Memorandum PECG's 2022-25 Understanding (MOU). That funding is included within the \$487.5 million the budget provides increased to pay compensation and health care costs required by MOUs that are currently in place. The proposed budget notes that the Administration will soon begin negotiations with 14 other state bargaining units that have MOUs that expire this summer. No money is included at this time for pay or benefit increases for those units.

In addition to the statutorily required \$8.5 billion payment to CalPERS, the proposed budget includes a \$1.2 billion supplemental payment to bolster the fund next year. The proposed budget also includes the state's required contributions to fund health care for active employees and retirees, and to meet the state's share of prefunding future retiree health care costs.

Of course, this is just the start of the budget process. The budget will go through review and ultimately be approved by the State Legislature over the next 6 months. PECG will be there to protect the interests of Unit 9 employees and will keep members up to date in the weeks ahead on any important developments. IN THE NEWS California Invests Nearly \$1 Billion for Transportation Improvements

The California Transportation Commission (CTC) allocated over \$988 million today to repair and improve transportation infrastructure throughout the state. This funding includes more than \$450 million from the federal Infrastructure Investment and Jobs Act of 2021 (IIJA) and more than \$250 million from Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017.

"The CTC's investments will help rebuild California's transportation infrastructure while increasing transit and active transportation options. These projects reflect the CTC and Caltrans' commitment to safety and meeting future challenges," said Caltrans Director Tony Tavares.

Projects the CTC approved include:

\$14,000,000 to design a suicide deterrent system for the San Diego-Coronado Bay Bridge and I-5 connector over-crossings to reduce the number of suicide attempts on the bridge. At the January meeting, The California Transportation Commission adopted this project into the State Highway Operation and Preservation Program (SHOPP).

"This funding allocation by the CTC is an important milestone in the Coronado Bay Bridge Suicide Deterrent Project. Last year, the project completed the environmental review process," said Caltrans District 11 Director Gustavo Dallarda. "This new funding is an important next step to allow Caltrans to move into the final design phase of the project. An untraditional project for Caltrans, but an important one that will have a big impact on the lives of many Californians."

SB 1 provides \$5 billion in transportation funding that is shared equally between the state and local agencies annually. Road projects progress through construction phases more quickly based on the availability of SB 1 funds, including projects that are partially funded by SB 1. The dump day event is part of Governor Gavin Newsom's Clean California initiative, a sweeping \$1.2 billion, multiyear clean-up effort led by Caltrans to keep roads and waterways free of litter, create thousands of jobs, and transform state and local public spaces through beautification efforts. As part of the litter collection component, Caltrans is hosting free dump day events where the public can dispose of household waste safely and properly for free to decrease highway debris and illegal dumping. Caltrans District 11 has held more than 25 such events in San Diego and Imperial Counties since launching Clean California in Summer 2021. Prohibited items that will not be accepted include hazardous waste (batteries, paint, oils, flammables, etc.), construction debris (concrete, dirt, asphalt, asbestos), compressed gas, aerosols, treated wood waste, refrigerators, and freezers. Four mattresses and four tires separated from the rims will be accepted per household.
